He is pictured below with his granddaughter Lauren and fellow shipmate Fred Grabos at 2011 reunion.



Carl R. Duquette (12/31/1925-01/6/2012)

Carl Raymond Duquette, of Bradenton, Florida, 86, passed away unexpectedly on January 6. 2012. He was the son of Wilfred Joseph Duquette and Marie Anne Laure Breault Browe. Born in Woonsocket, Rhode Island, Carl enlisted in the Navy in 1943 as a Torpedo man. During WWII he was assigned to the USS Gambier Bay. He served bravely, and survived three days adrift in the sea when his ship was attacked and sunk in the Leyte Gulf. Carl received an honorable discharge in 1946. Later he graduated from Bryant College in 1949 with a degree in accounting. He worked overseas, in Manhattan and for the Papers Workers Union in D.C. and in Albany, N.Y. He eventually applied for an accounting position with the State of New York where he worked until his retirement in the 1990's. He relocated to Florida and became an avid golfer and took up woodcarving. He is survived by his former wife, Julia Ainsburg; children, Charles Duquette, Laurie McGinley and Yvette Piper; grandchildren, Mara and Katherine McGinley and Rachael Piper. A memorial Mass was held at the Church of St Joseph, Stuyvesant Falls, N.Y., on January 25, at 9:00 a.m.

Paul Bennett (1/8/1922-2/28/2012

Paul A. Bennett, beloved father, and grandfather, died peacefully, surrounded by his family, to be with his Savior on Tuesday, February 28,2012 at the age of 90. Lt. JG Paul A. Bennett, USNR, was born January 8, 1922 in Milnor, North Dakota. In 1941 he worked in California for North American Aviation, where he worked on the final assembly of the first Ninety five B-25 bombers built for the Army. He enlisted in the U.S. Navy early in 1942 after the attack on Pearl Harbor. Paul served two tours of duty as a carrier-based pilot in the Pacific with Composite

Squadron VC-10 flying TBM Avenger torpedo bombers. He served on the USS Gambier Bay, until it was sunk during the Battle of Leyte Gulf. Paul was awarded the Silver Star and the Air Medal for his heroic attacks on enemy ships during the battle.

He returned to college in 1946 and received a BSME from North Dakota State, was then appointed a Grad Research Assistant at Purdue University, and received a MSME degree from

Purdue in 1952. While in college he married Ruth Lovas on December 28, 1946. They had 4 children. Randy (Carolyn) of Mt. Pleasant MI; Joyce (Don) Ross of Lansing MI; Cindy (Andy) Deveau of St. Johns MI; and Tim (Kris) of Spooner WI. They also had 8 grandchildren and 5 great grandchildren. Paul is survived by his sisters, Alice (Don) Lee of Milner, ND and June Jorgenson of Lisbon, ND. Ruth Lorayne (Lovas) Bennett died on March 10, 2006 and son Randy in 2007.

After graduating from Purdue, Paul worked 45 years as an automotive engineer, improving the performance of petroleum products in internal combustion engines. His research resulted in a number of design changes. Most significant was his patent for developing the PCV valve, now standard emissions equipment on all cars world wide. His work earned him international recognition, and he was honored by his selection as an SAE (Society of Automotive Engineers) Fellow. He also worked as a consultant to the U. S. Army, engine manufacturers, the petroleum industry, and served as an expert witness in several lawsuits, before his retirement in 1997.

Funeral services will be 11:00 A.M. Saturday, March 3, 2012 at St. Johns Lutheran Church, 511 E. Sturgis St. Johns with Rev. Dr. Bryan Salminen officiating. Interment will follow at South Bingham Cemetery with military honors provided by the St. Johns Honor Guard. The family will receive friends from 2-4 and 6-8 pm Friday, March 2, 2012 at Keck-Coleman Funeral Home, St. Johns. Memorials may be made to the Bennett Endowment Fund at St. John Lutheran Church.

Dear Gambier Bay Association Members,

During the October reunion in Omaha, I volunteered to edit and publish an E-Book compilation of Gambier Bay articles, photos and stories as another way to preserve and pass on the legacy of Gambier Bay survivors and their family members for future generations. My inspiration for this project evolved from my desire to publish the account written by my father, Lt. Robert G. Young, who served as Gunnery Officer on board the USS Gambier Bay. Then in reading Norm Loate's well written story as well as John Hagerty's piece entitled "The Next Generation", I began to envision the potential for creating an "E-book" anthology "in the words of the men of the Gambier Bay" and their family members.

In December, I wrote an article for the Scuttlebutt to determine the degree of interest among members in sharing any material (stories, memorabilia, letters, photos, etc.) that could be used to produce an E-Book with recollections by survivors and family members of their Gambier Bay experiences. Since then, I was delighted to receive emails from Andy Deveau, the son-in-law of Paul Bennett, one of the Gambier Bay's TBM pilots who launched his plane off the deck just before the ship sank. Andy encouraged Paul, who recently celebrated his 90th birthday, to write his Gambier Bay recollections which Andy then emailed me. Many thanks to Paul and Andy for contributing an excellent story for inclusion in the E-Book project.



How many of you remember Kilroy? Kilroy was a legend during WWII and afterward some of the fame lingered. Here is the story.





This is interesting ... I have often wondered about Kilroy ... now I know. Great piece of history. Anyone born in the mid thirties (or earlier) knew Kilroy. We didn't know why but we had lapel pins with his nose hanging over the label and the top of his face above his nose with his hands hanging over the label too. I believe it was orange colored. No one knew why he was so well known but we all joined in. Kind of a war story, now we know.

KILROY WAS HERE. WHO THE HECK WAS KILROY? In 1946 the American Transit Association, through its radio program, "Speak to America" sponsored a nationwide contest to find the REAL Kilroy, offering a prize of a real trolley car to the person who could prove himself to be the genuine article.

Almost 40 men stepped forward to make that claim, but only James Kilroy from Halifax, Massachusetts. had evidence of his identity.

Kilroy was a 46-year old shipyard worker during the war who worked as a checker at the Fore River Shipyard in Quincy. His job was to go around and check on the number of rivets completed. Riveters were on piecework and got paid by the rivet.

Kilroy would count a block of rivets and put a check mark in semi-waxed lumber chalk, so the rivets wouldn't be counted twice. When Kilroy went off duty, the riveters would erase the mark. Later on, an off-shift inspector would come through and count the rivets a second time, resulting in double pay for the riveters.

One day Kilroy's boss called him into his office. The foreman was upset about all the wages being paid to riveters, and asked him to investigate. It was then he realized what had been going on.

The tight spaces he had to crawl in to check the rivets didn't lend themselves to lugging around a paint can and brush, so Kilroy decided to stick with the waxy chalk. He continued to put his checkmark on each job he inspected, but added KILROY WAS HERE in king-sized letters next to the check, and eventually added the sketch of the chap with the long nose peering over the fence and that became part of the Kilroy message. Once he did that, the riveters stopped trying to wipe away his marks.

Ordinarily the rivets and chalk marks would have been covered up with paint. With war on, however, ships were leaving the Quincy Yard so fast that there wasn't time to paint them. As a result, Kilroy's inspection "trademark" was seen by thousands of servicemen who boarded the troopships the yard produced. His message apparently rang a bell with the servicemen, because they picked it up and spread it all over

Europe and the South Pacific. Before war's end, "Kilroy" had been here, there, and everywhere on the long hauls to Berlin and Tokyo.

Kilroy continued

To the troops outbound in those ships, however, he was a complete mystery; all they knew for sure was that some jerk named Kilroy had "been there first." As a joke, U.S. servicemen began placing the graffiti wherever they landed, claiming it was already there when they arrived.

Kilroy became the U.S. super-GI who had always "already been" wherever GIs went. It became a challenge to place the logo in the most unlikely places imaginable (it is said to be atop Mt. Everest, the Statue of Liberty, the underside of the Arc De Triumphe, and even scrawled in the dust on the moon).

As the war went on, the legend grew. Underwater demolition teams routinely sneaked ashore Japanese-held islands in the Pacific to map the terrain for coming invasions by U.S. troops (and thus, presumably, were the first GI's there). On one occasion, however, they reported seeing enemy troops painting over the Kilroy logo. In 1945. an outhouse was built for the exclusive use of Roosevelt, Stalin, and Churchill at the Potsdam conference. Its first occupant was Stalin, who emerged and asked his aide (in Russian), "Who is Kilroy?"

To help prove his authenticity in 1946, James Kilroy brought along officials from the shipyard and some of the riveters. He won the trolley car, which he gave to his nine children as a Christmas gift and set it up as a playhouse in the Kilroy front yard in Halifax, Massachusetts.

If you check the WWII memorial in Washington DC, you will see Kilroy peeking over a wall. So, now you Know! I did take a picture of Kilroy when we were in DC in 2005.

Ex-Sailors Are Reunited 25 Years After Ordeal

A tall man sidestepped a cluster of heavily engaged conversationalists, raising a bottle of beer above the crush, and confronted a shorter man Friday at the Gateway Hotel.

"You son of a gun, you didn't tell me you were coming," the tall man shouted.

The shorter man s q u i n t e d through his glasses, examined the other man's name tag while standing on tip toe, and said, "Why you ... you've changed."

It was exactly 25 years to the day since the two men had been aboard the G a m b i e r Bay, a thin-hulled American baby aircraft carrier, when it was sunk by J a p a n e s e ships in Leyte Gulf, The Phillippines.

200 Are Gathered

This weekend, many miles from salt water, about 200 former crew members of the Gambier Bay are gathered. For most, it is the first meeting since they were rescued from the sea on that day a quarter of a century ago.

Officially, this meeting of now middle-aged men, some with little hair and bulging waistlines, represented the first reunion of what is called the U.S.S. Gambier Bay V.C. 10 Association, the latest version of a World War II veteran's organization.

The ship, in Navy terminology, was an escort carrier. It had planes, guns and 1100 men. Some of the sailors who survived the sinking—now real estate men, school teachers, owners of metal fabricating firms, and in other fields—were brought together as a result of more than a year's research by three former shipmates.

The three, Anthony Potochniak of Endicott, N.Y., Martin Showers, Akron, O. and Charles G. Heinl, Maria Stein, O., had spent their spare time dogging the Department of Defense, members of Congress and Navy officials, in an attempt to trace the 5 survivors of the sinking. Aided By Washington

Finally, after finding help in Washington, the three were able to compile a list of 425 survivors. Letters of invitation were sent.

Much of the activity at this first reunion involved attempts to find "some of the boys you spent time on a raft with." All of the crew of the Gambier Bay spent at least two days and two n i g h t s in the ocean, before b e i n g rescued. Several others recall floating many more days.

Lloyd Carothers, a Portland, Ore., high school English teacher, had recollections that were at times sad.

"There were 24 of us hanging onto a piece of plank from the flight deck," he said. "Later, when we were picked out of the water, there were eight. Some lost their grip after taking in too much salt water. Others, in a delusional state, swam away to what they thought was the sound of an approaching ship."

"Everybody here loves the Navy," said another man. "There are at least 200 different and sometimes heroic stories in this room."

"Why we are here," said George LeGrath, a Milwaukee, Wis., plant superintendent, "is something the kids don't understand. It's not patriotism particularly. It's a common experience. You just want to see the guys you shared it with. We're not flag-waving."

AFTER 45 HOURS AT SEA IN A LIFEBELT

Seaman Hits Deck 'Like Dish Rag'

PICKED UP after floating in South Pacific waters 45 hours, Edward S. Hagerty, Jr., 19, S1c, told today how he stepped on the deck of the res-

cuing ship, only to "hit the deck like a wet dish rag."

Hagerty arrived home Thursday with the first group of Minneapolis men to return from the

sunken escort carrier Gambler Bay.

He told his mother how, after a Japanese cruiser destroyed his carrier with point-blank shell fire, he and the surviving crew members went overboard with only their carbon-dioxide inflated lifebelts to keep them afloat.

He brought his life belt home as a souvenir.

For two days and nights, Hagerty and his companion drifted, while small craft from the newly-won beachhead on Leyte searched for survivors. There were only enough life rafts to take care of the wounded men.

His most vivid recollection is of a dentist from the Gambier Bay, who treated all the wounded aboard the rafts, even before applying a tourniquet to his own badly wounded leg.

Typical of the spirit of young American sailors, Hagerty said that as soon as he finishes his present 30-day leave with his parents, Mr. and Mrs. E. S. Hagerty, 415 Fifth avenue SE., he will try to get aboard another carrier.

All but one of the planes aboard the Gambier Bay managed to fly to safety.
