


So I have a few questions about Mr Shlesman, that I thought you might be able to answer:


I talked to Mr. Shlesman and he was pleased that we wanted to put this correspondence in the Scuttlebutt as is Benoit (from France).

Henry Anthony Pyzdrowski Sr. 8/9/22-4/11/2011

Age 88, of Minnetonka, passed away on Monday, April 11, 2011. Henry was preceded in death by his parents, Anthony and Antoinette; siblings, Thaddeus, Walter and Wanda; son, Henry Anthony, Jr.; and granddaughter, Stephanie Anne Fraune. Survived by his loving wife of 63 years, Jeanne Frances (Smith); and their children, Jeanne Fraune (John), Michael (Joan), Patricia Seeler (Thomas), Robert (Sue), Paul (Karen), John (Deborah), Mary Anne Pickering (John), Kathryn (Thomas Nelson), Margaret (Michael Brown), Caroline Gossen (Jeffrey); brother, Stanley S. Pyzdrowski; numerous nieces and nephews; and thirty-four beloved grandchildren. Born in Pittsburgh, PA on August 9, 1922, Hank attended Schenley High School, where he met Jeanne. Growing up, he was an avid Pittsburgh Pirates fan, pursued flying at Butler County Airport, and worked at his father's architectural firm which significantly contributed to the architecture in and around Pittsburgh. Hank attended Carnegie Mellon University in Pittsburgh. His college career was interrupted by active military service in the U.S. Navy where he served in the Pacific Theater as a Naval Aviator in WWII (1942-1945). He is a graduate of Carnegie Mellon University (1945) and Northrop University (1946). During his adult life, Hank devoted his efforts as a benefactor and leader for the community, actively participating in the VFW, Knights of Columbus, his Church and providing assistance to area schools and Veterans associations, having most recently served as President, Board of Governors, Escort Carrier Sailors and Airmen Association. Professional career: Aeronautical Engineer, Northrop Aviation (1947-1948); Engineer/General Manager, Central Oregon Iron Works, Bend, OR (1948-1958); General Manager, Superior Separator, Hopkins, MN (1958- 1963); and President, Sacred Design Associates, Minneapolis, MN (1963-2002). Hank dedicated his later years to the preservation of the memory of his shipmates of the aircraft carrier, USS Gambier Bay, over 100 of whom were lost in the Battle of Leyte Gulf on October 25, 1944. An adventurer. Hank and Jeanne raised eleven children, with Dad devoting his life to his family, instilling a strong work ethic and sincere appreciation for life. He is and will remain known for his genuine passion, honesty and integrity, endless encouragement, sense of humor and unending wisdom. JOSEPH E. MANTZ- (1921-2011)

age 89, of Dayton, passed away peacefully Sunday, March 13, 2011. Joseph is survived by his wife of 62 years, Eleanor; daughters, Barbara (Frederick) Kreuzer, Catherine (Jerome) Roberts, Susan (Richard) Humphrey, Christine (Joseph) Fletcher; son, Joseph (Samantha); brother, Christian (Bernice); 3 sisters-in-law; 8 grandchildren; 5 great-grandchildren; and numerous other relatives and friends.

Joseph was a WWII Veteran & served on the USS Gambier Bay (CVE-73), which sank during the Battle of the Leyte Gulf. For wounds received in action, Joseph was awarded a Purple Heart. Joseph retired from the National Museum of the United States Air Force where he helped to restore historic aircraft. He was a charter member of St. Luke Parish in Beavercreek and served as an usher there for many years. Joseph was also active in the St. Luke Leisure Club, Beavercreek Senior Citizens, Knights of Lithuania, DAV, American Legion, VFW, the Military Order of the Purple Heart, where he served for one year as the Commander for the State of Ohio, and volunteered at the Veterans Hospital. He was a member of Holy Cross Church and later joined St. Peter Parish.

In Memoriam

John Ivie 8/25/1925-1/26/11

John Ivie Passed on January 26, 2011. John was a naval veteran of <u>WWII</u>. His carrier, the Gambier Bay, was sunk during the 2nd battle for the Philippines in the Leyte Gulf, October 20th through 26th, 1944. It was also declared the greatest sea battle in naval history.

John was born in Pasadena, CA on August 11, 1925. After the war he became a pilot with Western Airlines and later a flight instructor in the San Francisco Bay Area teaching many prominent clients.

John is remembered as being a fine teacher. When he retired he learned to fly gliders, thus moving to Lancaster for its great weather. John leaves behind his son Kenyon Ivie of Hawaii, his niece Claudia Glastaun, and three nephews, Gregory Damon, William Damon, Bryan Damon and John's sister Joan Damon. He also leaves behind many devoted friends.

Edward T. Bridges (1924 - 1/31/2011)

Edward T. Bridges, 87, of Swansea, III., born Thursday, Jan. 3, 1924, in East St. Louis, III., died Monday, Jan. 31, 2011, at Caseyville Nursing & Rehabilitation Center in Caseyville, III.

Mr. Bridges was a <u>U.S. Navy</u> Veteran of <u>World War II</u> and served on the aircraft carrier UUS Gambier Bay which was sunk in the battle of Leyte Gulf by the Japanese. Mr. Bridges survived after spending 40 hours in the water. He worked as a carpenter for 30 years for Piquard Construction Company and in retirement he enjoyed woodworking in his work shop. He was a member of the Carpenters Union for 50 years and was a member of Westview Baptist Church in Swansea, III.
